ABC-VA APPRENTICESHIP

ABC Virginia has a long history of providing high quality, student-centered learning with an emphasis on hands-on training. Our goal is to give individuals the opportunity to learn a trade, become skilled crafts professionals, earn a good living, and build Virginia.

Through our educational affiliate, National Center for Construction Education and Research (NCCER), we use Contren, a competency-based, task-driven, and nationally recognized curriculum. ABC-VA instructors are required to complete a formal certification in order to ensure consistent delivery of the curriculum.

ELIGIBILITY

- 18 years of age or older
- Employed in the plumbing field
- Physically able to perform work in the plumbing trade
- Must be able to read and write in English
- High school diploma or GED equivalent

RELATED TRAINING

By providing employers with the Advisory Apprenticeship Program Standards, ABC-VA delivers the related classroom training component of apprenticeship.

VIRGINIA WORKS REGISTRATION

Employers must register as apprenticeship program sponsors and must register their apprentices on an individual basis with Virginia Works (formerly Virginia Department of Labor and Industry).

Without this registration, a student is not considered an apprentice in the state of Virginia.

Participation in the plumbing apprenticeship program will be strictly limited to apprentices that are employed by companies that are duly licensed as plumbing contractors in Virginia.

PREREQUISITES

All incoming Level I students will be required to take a math assessment. Students without a passing grade will be required to attend a **mandatory** math tutoring course at ABC-VA prior to the course (\$55 per person, offered 8/11-8/14 from 4-7PM).

2025-2026 APPRENTICESHIP SCHEDULE

The term of apprenticeship consists of four years or 8,000 hours (approximately 2,000 hours per year) of on-the-job training (OJT) and four years or 600 hours (approximately 150 hours per year) of related classroom instruction. OJT is administered by the student's employer. Related classroom instruction is administered by ABC-VA.

Tuition is due at time of enrollment. Apprentices employed by ABC-VA members receive a discount. Tuition includes lab, materials and administrative fees. Tuition must be paid in full for apprentices to be considered enrolled.
